- WEATHER GUARD® headache racks are designed to work with WEATHER GUARD® Mounting Channel kits to provide the best support for your load
- Review vehicle manufacturer's rail mount recommendation.
- Perform the installation on a level surface.
- Always wear protective eyewear to keep debris out of your eyes when installing WEATHER GUARD® Truck Products.
- Tighten all 5/16" hardware to 13 ft-lb when ready.
- Tighten all 1/4" hardware to 76 in-lb when ready.
- This product is designed and intended for use on the following full size trucks: Ford F-150 & F-250, Ram 1500 & 2500, GMC Sierra, Chevrolet Silverado

OPERATION GUIDELINES


- Ladders transported on a vehicle should be properly supported and the overhang of the ladders beyond supporting points should be limited. Transporting a ladder with excessive overhang can result in reduced ladder life. Inspect your ladder before each use. Follow ANSI 14.2-2007 for direction on securing ladders to ladder racks.
- It is the responsibility of the user to secure the load to the rack before transporting.
- Any modifications made to this product, or use of this product for any other purpose than its intended use, could create a hazardous condition that can cause serious personal injury or property damage.
- Material must be contained within the side rails of the rack
- Adhere to DOT and state requirement when transporting material on the rack
- Properly rated straps must be used when securing material to the rack
- At the end of the first week of use, check all of the fasteners for proper tightness and then check every three
 months thereafter






Assemble frame to upper bracket mount (Reference Page 2 for Height Adjustment). Tighten using 5/16" Allen Socket or Allen Wrench and 3/4" Hex Socket or Wrench such that the nut is flush with the end of the bolt. Repeat on all four 1/2" bolts.




Place both the lower brackets in the far back corners. Position the Upper assembly onto the lower bracket using the threaded stubs to locate.



Mark appropriate points for drilling. (See reference on page 2 for appropriate configuration). Use alignment punch and a hammer to insure correct positioning. Use step drill bit or 1/2" drill bit for the blind fastener and 5/16" drill bit for the carriage bolt mounting holes. Once drilled position lower bracket and loosely tighten fasteners. Use 5/16"- 18×1 -1/4" bolts, 5/16" washers, and lock washers to fasten to the blind fasteners. Use 5/16"- 18×1 -1/4" carriage bolts, 5/16" washers, and 5/16"- 18×1 - 18×1 -




Place upper assembly over the lower fastened bracket using the studs to locate. Use the fender washers and 5/16" lock-nuts to fasten the upper assembly to the lower bracket.





Fully tighten all bolts and nuts. Tighten the 1/2" bolts such that 1/8" of threads are showing.




BRACKET DIAGRAMS










